

## NAVIGABLE AIRSPACE DETERMINATION: 17 Hickory Place, Hornby, Christchurch.

<u>PURSUANT TO</u> Rule Part 77 of the Civil Aviation Rules I, Sean Turangarau Kere Rogers, Manager Aeronautical Services, having received a request from Titan Cranes Limited, Christchurch Branch, a notification of intention to operate a crane at 17 Hickory Place, Hornby, Christchurch conducted an aeronautical study in consultation with such persons, representatives and organisations as I considered appropriate.

After completing the aeronautical study, I am satisfied that the proposed action, if executed, could constitute a hazard in navigable airspace.

THEREFORE I HEREBY ISSUE a

## **DETERMINATION OF HAZARD IN NAVIGABLE AIRSPACE**

in respect of the above notification.

The following conditions are specific to this Determination:

- Prior to the operation of the crane, Titan Cranes Limited, Christchurch Branch, is to establish an agreed plan of operations with Ford Robertson at Christchurch International Airport Limited (CIAL)
   (Ford.Robertson@cial.co.nz); and
- 2. Ford Robertson at CIAL is to brief Airways Air Traffic Control and Canterbury Aeroclub to ensure agreed procedures are in place and documented appropriately, including a NOTAM, to ensure the safety of VFR traffic when the crane is operating; and
- 3. Titan Cranes Limited, Christchurch Branch is to liaise with Ford Robertson at CIAL to confirm the necessary NOTAMs are in place prior to each operating period; and
- 4. The crane is to be lit IAW CAR Part 77, Appendix B; and
- 5. The crane is not to exceed a height of 94m AGL; and
- 6. The crane is to be operated in daylight only; and
- 7. The crane is to be lowered to below the obstacle limitation surface when not in use; and

The provisions of this determination are in addition to and not in derogation of the provisions of any other Act, or any orders or regulations made thereunder.

- 8. When the crane operation is completed, Titan Cranes Limited, Christchurch Branch, is to contact Ford Robertson at CIAL to ensure that all procedures are restored to normal; and
- 9. When the crane operation is completed, Titan Cranes Limited, Christchurch Branch, is to notify CAA Quote 23/77/36 to aeronautical.services@caa.govt.nz.

This Determination of Hazard shall become final on  $14^{th}$  April 2023 unless a petition for review is received by the Director prior to that date.

This Determination of Hazard shall not expire but may be revoked, in writing, by the Director.
