

NAVIGABLE AIRSPACE DETERMINATION: 95 Orchard Road, Harewood.

<u>PURSUANT TO</u> Rule Part 77 of the Civil Aviation Rules I, Sean Turangarau Kere Rogers, Head of Aeronautical Services, having received a request from Apollo Projects Limited, a notification of intention to operate a crane at 95 Orchard Road, Harewood, conducted an aeronautical study in consultation with such persons, representatives and organisations as I considered appropriate.

After completing the aeronautical study, I am satisfied that the proposed action, if executed, could constitute a hazard in navigable airspace.

THEREFORE I HEREBY ISSUE a

DETERMINATION OF HAZARD IN NAVIGABLE AIRSPACE

in respect of the above notification.

The following conditions are specific to this Determination:

- 1. Prior to the operation of the crane, Apollo Projects Limited is to establish an agreed plan of operations with Ford Robertson at Christchurch International Airport Limited (CIAL) (Ford.Robertson@cial.co.nz); and
- 2. As soon as an operating date is confirmed, Apollo Projects Limited is to contact Aeropath (Quote 2025-01089 to Part77@aeropath.aero) and request the instrument flight procedures are adjusted by NOTAM according to the Aeropath assessment; and
- 3. Ford Robertson at CIAL is to brief Airways Air Traffic Control and the local user group/s for their situational awareness and to issue a NOTAM for the duration; and
- 4. Before operations commence, Apollo Projects Limited, Christchurch Branch is to liaise with Ford Robertson at CIAL to confirm the necessary NOTAMs are in place as above; and
- 5. The crane is to be lit IAW CAR Part 77, Appendix B; and
- 6. The crane is not to exceed a height of 60m AGL; and
- 7. The crane is to be operated in daylight only; and
- 8. The crane is to be lowered to below the obstacle limitation surface (OLS) when not in use; and

The provisions of this determination are in addition to and not in derogation of the provisions of any other Act, or any orders or regulations made thereunder.



- 9. When the crane operation is completed and no longer in use, Apollo Projects Limited is to contact Aeropath (Quote 2025-01089 to Part77@aeropath.aero) and request the instrument flight procedures are restored to normal; and
- 10. When the crane operation is completed, Apollo Projects Limited is to contact Ford Robertson at CIAL to ensure that all procedures are restored to normal; and
- 11. When the crane operation is completed, Apollo Projects Limited is to notify CAA (Quote 2025-01089 to aeronautical.services@caa.govt.nz).

This Determination of Hazard shall become final on 24th September 2025 unless a petition for review is received by the Director prior to that date.

This Determination of Hazard shall not expire but may be revoked, in writing, by the Director.
