An offence against section 107 or 362 by an individual is punishable by a term of imprisonment not exceeding 12 months and/ or a fine not exceeding \$30,000, or for a person other than an individual a fine not exceeding \$100,000.

agree to notify the Aviation Security Service immediately if I am convicted of an offence prior to the expiry of my airport identity card;

note that information obtained for the purposes of the security check will be handled according to the principles of the Privacy Act 2020;

note that under the Privacy Act 2020 I have the right to request access to, or correction of, any personal information held by the Aviation Security Service.

I authorise the Aviation Security Service to disclose my personal information to New Zealand government border agencies including, New Zealand Customs Service (NZCS), Immigration New Zealand (INZ), Ministry for Primary Industries (MPI), Statistics New Zealand (Stats NZ), Ministry of Health, and Health New Zealand (together Health), and to the New Zealand Police.

DO I HAVE TO AGREE TO A SECURITY CHECK?

You must consent to the Aviation Security Service carrying out a security (background) check on you to determine whether you pose a threat to aviation security. If you refuse to consent to a security check, your application for an airport identity card will not be considered.

In carrying out a security check, we ask people or organisations to disclose information about you. For example, we can seek: a recommendation from the New Zealand Security Intelligence Service, information about your criminal record (if any) from the Ministry of Justice, or information from the New Zealand Customs Service or the New Zealand Immigration Service.

You and your employer will be informed whether you have received a favourable security check determination or an adverse security check determination. Advice to your employer will not include the reason for, or details of, any determination.

Favourable security check determination

You need to receive a favourable security check determination in order to be granted a permanent airport identity card.

Adverse security check determination

In the event of an adverse security check determination and your Airport Identity Card application being declined, you will be advised of your right to have that decision reviewed under section 128 of the Civil Aviation Act 2023.

However, if you wish to have an adverse determination reviewed that is based solely on a decision by the New Zealand Security Intelligence Service under section 11 of the Intelligence and Security Act 2017, in accordance with section 171 of the Act, you must make a complaint to the Inspector-General of Intelligence and Security instead.

The Director of Civil Aviation may, at any time, reconsider a previous favourable security check determination if new information is made available, or if there is reason to suspect that a person may pose a threat to aviation security (sections 126 and 127, Civil Aviation Act 2023).
