# **Medical Manual**

Four chapters are available on the CAA website. These are Ophthalmology, ENT, Respiratory and Neurology. The current web versions are still drafts. Those chapters have been finalised but are waiting to go through an internal process prior to publication. Meanwhile you may refer to the drafts. You are very welcome to ask questions and make suggestions if anything is unclear. We are currently working on the cardiology chapter.

# Rule 61.35

This stipulates that a person who holds a pilot licence issued in accordance with this Part [Rule Part 67] must not exercise the privileges of the licence, unless—

(1) the person—

(i) in the case of a private pilot licence, holds at least a current class 2 medical certificate issued under the Act; and

(ii) in the case of a commercial or senior commercial pilot licence and an airline transport pilot licence, holds a current class 1 medical certificate issued under the Act; and
(iii) is complying with all the conditions, restrictions and endorsements on the medical certificate.

CAA has identified a number of cases where the prescribed surveillance has not taken place in a timely fashion, or not at all.

The flight safety or financial consequences of such non-compliance may be dear as flying becomes illegal.

You can assist CAA and your applicant by emphasizing to your clients the provisions of this Rule. In summary non-compliance in a timely fashion = No flying.
