A brief update from Aviation Medicine Team



Dear Colleagues,

Airline Pilots over age 60 flying internationally, particularly into the USA

As you may be aware, the US only accepts a 6 month validity for Class 1 medical certificates if the pilot is aged 60 years or over at the time of the examination, in accordance with ICAO Standards and Recommended Practices.

When issuing a certificate to a 60+ year old airline pilot flying into the USA, the Class 1 expiry dates should be limited to 6 months to comply with the FAA requirements. We recommend discussing with the pilot the destination they fly into and the certificate duration.

Whilst CAA permits a 12 month currency for Class 1 for operations other than single pilot air operations carrying passengers (multicrew), limiting the certificate's validity will avoid inconvenience to the pilot should they be submitted to a FAA spot check when flying in or out of the US.

Acceptable dose of Prednisone

This question has been asked quite frequently. CAA accepts Prednisone use up to 10 mg daily, provided that the condition being treated is itself acceptable and there are no concerns to flight safety

EMPIC Project

The EMPIC project is currently developing the personnel licensing modules for pilots and aircraft engineers to be rolled out the end of June. The EMPIC project is also recommencing work on the medical module in May. The vendor, EMPIC, has proposed a new specification to better meet our NZ requirements.

The project and the CAA Medical unit will be seeking input into the new medical module from key stakeholders. If you would like to be involved, please let us know and we can register your interest with the project team.

CAA – CASA Harmonisation

The two medical teams have resumed work towards harmonisation beween CAA & CASA. This is to achieve more commonality between our respective requirements.
