## Rule objective

The objective of amendment 15 to Part 19 is to make minor editorial and minor technical changes and to update the rule in accordance with current International Civil Aviation Organization (ICAO) abbreviations.

Amendment 15 to Part 19 is constituent to NPRM 09-03 which contains amendments to the following Parts:

### Extent of consultation

A Notice of Proposed Rulemaking, NPRM 09-03, containing the proposed changes to Part 19 and changes to other rules was issued for public consultation under Docket 9/CAR/1 on 30 July 2009.

The publication of this NPRM was notified in the Gazette on 31 July 2009 and advertised in the daily newspapers in the five main provincial centres on 31 July 2009. The NPRM was published on the CAA web site on 30 July 2009.

A period of 37 days was allowed for comment on the proposed rule.

## Summary of submissions

A total of 3 written submissions were received on NPRM 09-03 (1 submission related to Part 1, and 2 submissions related to Part 91). However, no submissions were received relating to Part 19, and consequently no changes were made to the proposed amendments.

The rule was then referred to the Minister of Transport for signing.

### **Examination of submissions**

Submissions may be examined by application to the Docket Clerk at the Civil Aviation Authority between 8:30 am and 4:30 pm on weekdays, except statutory holidays.

#### **Insertion of Amendments**

The amendments to the rules in this Part are reflected by the revocation of 2 existing rules and the insertion of new rules.

### Effective date of rule

Amendment 15 to Part 19 comes into force on 25 March 2010.

# Part 19 Amendments

# Subpart A — General

#### Rule 19.3 is revoked and replaced by the following rule:

### 19.3 Units of measure

(a) Subject to paragraph (b), the units of measure used for aeronautical purposes in New Zealand are those specified in the International System of Units as adopted in Annex 5 to the Convention.

(b) Non International System Units adopted by Annex 5 are used in accordance with the following table in New Zealand:

distance	nautical miles
altitude, elevation, and height (when associated with the operation of aircraft)	feet
visibility	kilometres or metres
speed, including wind speed	knots
vertical speed	feet per minute

# Subpart D — IFR Operations: GNSS

Rule 19.213 is revoked and replaced by the following rule:

### 19.213 GPS derived distance information

(a) A pilot-in-command of an aircraft operating under IFR using GPS equipment must not use GPS derived distance information if RAIM is unavailable and has been unavailable for the preceding 10 minutes.

(b) The pilot-in-command must, when using GPS derived distance information in a position report, state the distance as a *GPS distance* 

relative to a specified reference point that is contained in the GPS database.

(c) The pilot-in-command must, when using GPS derived distance information on an ILS/DME or LOC/DME instrument approach procedure, ensure —

- (1) that the GPS distance information is based on the coordinates of the DME that is associated with the current published instrument approach procedure; and
- (2) that current data for the DME co-ordinates is permanently stored in the GPS database.

#### **Consultation Details**

(This statement does not form part of the rules contained in Part 19. It provides details of the consultation undertaken in making the rules.)

A Notice of Proposed Rulemaking, NPRM 09-03 Omnibus 2009, containing the proposed rule amendments for Part 19, and other proposed rule amendments in various Parts, was issued for public consultation under Docket 9/CAR/1 on 30 July 2009.

A period of 37 days was allowed for comment on the proposed rule.

A total of 3 written submissions were received on NPRM 09-03 (1 submission related to Part 1, and 2 submissions related to Part 91). However, no submissions were received relating to Part 19.

The purpose of NPRM 09-03 was to make minor editorial and minor technical amendments to various Parts of the Civil Aviation Rules (CAR). The proposed amendments included the correction of spelling and grammatical errors, the updating of various rules in accordance with current International Civil Aviation Organization (ICAO) standards, definitions and abbreviations, and the revocation of specific transitional arrangements.
