Rule objective

The objective of Amendment 6 to Part 119 is to make editorial and minor technical changes as part of a general rule fix up project.

Extent of consultation

A Notice of Proposed Rulemaking, NPRM 05-07, containing the proposed changes to Part 119 was issued for public consultation under Docket 3/CAR/4 on 23 June 2005.

The publication of this NPRM was notified in the *Gazette* on 23 June 2005 and advertised in the daily newspapers in the five main provincial centres on 25 June 2005. The NPRM was published on the CAA web site and mailed to identified stakeholders including representative organisations who were considered likely to have an interest in the proposal.

A period of 37 days was allowed for comment on the proposed rule.

New Zealand Transport Strategy

The development of the NPRM and the proposed rule changes takes into account the objectives of the New Zealand Transport Strategy (NZTS) and the provisions of the Civil Aviation Amendment Act (No 2) 2004.

Summary of submissions

Nine written submissions were received on the NPRM. No submissions were received on the proposed amendments to Part 119.

During drafting of the final rule editorial amendment was made to rule 119.15 to remove duplication with rule 119.9(2).

The rule as amended was then referred to Parliament's Regulations Review Committee before being signed by the Minister for Transport Safety.

Examination of submissions

Submissions may be examined by application to the Docket Clerk at the Civil Aviation Authority between 8:30 am and 4:30 pm on weekdays, except statutory holidays.

Insertion of Amendments

The amendments to the rules in this Part are reflected by the revocation of the existing rule and the substitution of the new rule.

Effective date of rule

Amendment 6 to Part 119 comes into force on 22 June 2006.

Part 119 Air Operator — Certification

Subpart A — General

Rule 119.15 is revoked and the following new rule is substituted:

119.15 Operations specifications

- (a) An air operator certificate issued in accordance with this Part must be accompanied by the operations specifications specified in paragraph (b).
- (b) The operations specifications must contain—
 - (1) details of the physical location of the certificate holder's principal base of operations; and
 - the certificate holder's address for service in New Zealand;
 and
 - (3) other business names under which the certificate holder may operate; and
 - (4) the type, serial number, and registration of every aircraft that is authorised for use; and
 - (5) details of the air operation types authorised; and
 - (6) the authorisation and limitations for routes and areas of operations; and
 - (7) any exemption granted from any requirement of this or any other Part; and
 - (8) any other item the Director determines is necessary to cover a particular situation.
- (c) When authorising SEIFR passenger operations in a certificate holder's operations specifications, the Director may specify that the authorisation is valid for a period less than that for which the air operator certificate is valid.

Subpart B — Airline Air Operator – Certification Requirements

Rule 119.75 is revoked and the following new rule is substituted:

119.75 Air operator security programme

An applicant for the grant of an airline air operator certificate that proposes to operate a regular air transport passenger service from or within New Zealand with any aircraft that has a passenger seating configuration (excluding any required crew member seats) of more than 9 seats must establish an air operator security programme that meets the requirements of Part 108.

Subpart D — Operating Requirements

Rule119.151 is revoked and the following new rule is substituted:

119.151 Continued compliance

- (a) A holder of an air operator certificate must comply with the operations specifications required by rule 119.15.
- (b) A holder of an air operator certificate must—
 - (1) continue to meet the standards and comply with the requirements of either Subpart B or Subpart C, as appropriate; and
 - (2) comply with every procedure and programme detailed in the certificate holder's exposition; and
 - (3) hold at least 1 current copy of the certificate holder's operations specifications and the relevant sections of the certificate holder's exposition applicable to the operation at the location, in hard copy, electronic, or other form acceptable to the Director, at each location specified in the certificate holder's exposition if the holder holds—
 - (i) an airline air operator certificate; or

(ii) a general aviation air operator certificate requiring an organisational management system in accordance with rule 119.124(c).

Appendix B — Qualifications and Experience of Senior Persons – General Aviation Air Operator Certificate Holder

Appendix B.1 is revoked and the following new appendix is substituted:

Comments arising from the NPRM

The rule amendment was developed under Docket 3/CAR/4 and published as NPRM 05-07. The consultation details relating to Docket 3/CAR/4 are detailed in each affected rule.

Nine written submissions were received on the NPRM and none commented on the proposed amendments to Part 119.
