#### **Extent of consultation**

A Notice of Proposed Rulemaking, NPRM 15-01, containing the proposed changes to Part 119 and other rules was issued for public consultation under Docket 14/CAR/3 on 24 March 2015.

The publication of this NPRM was notified in the Gazette on 24 March 2015. The NPRM was published on the CAA web site and emailed to subscribers to the automatic alert service provided by the CAA.

A period of 24 days was allowed for comment on the proposed rule.

# Summary of submissions

Two written submissions and no oral comments were received on the NPRM. No submissions related to the proposed amendment to Part 119.

#### **Examination of submissions**

Submissions may be examined by application to the Docket Clerk at the Civil Aviation Authority between 8:30 am and 4:30 pm on weekdays, except statutory holidays.

#### Insertion of Amendments

The amendment to the rule in this Part is reflected by replacing the existing rule with the amended rule.

### Effective date of rule

Amendment 14 to Part 119 comes into force on 24 September 2015.

### Replace the existing rule 119.5 with the following rule 119.5:

## 119.5 Requirement for certificate

- (a) A person having operational responsibility for an air operation must hold, and comply with, an air operator certificate issued under this Part.
- (b) Except for an adventure aviation operation, a person must not perform an air operation except under the authority of, and in accordance with the privileges of, an air operator certificate issued under the Act and this Part.
- (c) For the purpose of paragraph (a) a person has operational responsibility for an air operation if the person has responsibility for two or more of the following functions:
  - (1) determining whether the operation may be operated safely:
  - (2) assigning crew members for the operation:
  - (3) employing, contracting, or otherwise engaging crew members for the operation:
  - (4) making a decision to vary the operation, other than a decision by the pilot-in-command taken on the grounds of safety.
