### Rule objective

The objective of amendment 7 to Part 139 is to implement the consequential amendments to the Civil Aviation Rules in accordance with sections 2(2) and 19(3) of the Civil Aviation Amendment Act 2007, and clause 2 of the Civil Aviation Amendment Act 2007 Commencement Act 2007/404.

#### Part 139 Amendments

#### Subpart D — Aerodrome Security

#### Rule 139.203(a)

Insert "or security enhanced area" after "security area".

### Rule 139.203(b)(1)

Insert "or security enhanced areas" after "security areas".

#### Rule 139.203(b)(2)

Omit "the security area or security areas" and substitute "any security area or security enhanced area".

#### Rule 139.203(c)

Omit "the security area or security areas" and substitute "any security area or security enhanced area".

#### Rule 139.203(d)

Insert after paragraph (4):

"(4A) when considered necessary by the Minister or the Director, provide areas at their aerodrome for the screening and searching of persons, items, substances, and vehicles entering and within security enhanced areas; and"

## Rule 139.203(d)(11)

Insert "or security enhanced areas" after "security areas".

Insert "and under 139.203(d)(4A)" after "baggage)".
