**AVSEC National Inspectors Course scheduled 15-23 July 2026**

The Auckland ICAO Aviation Security Training Centre (ASTC) has scheduled the AVSEC National Inspectors course to be held over the dates of 15 – 23 July 2026. The course duration is seven-days, and the course attendance times are 0900 – 1700hrs (NZT).

The Auckland ICAO ASTC, as one of the ICAO Aviation Security Training Centres within the APAC region has a fundamental role to play in assisting States within the APAC region in strengthening their capacity building efforts and enhancing their capability to implement International Standards and Recommended Practices.

The National Inspectors Course curriculum is designed to provide aviation security personnel with theoretical and practical knowledge of audits and inspections as part of a National Quality Control system. Participants who successfully complete this course will be prepared to plan, coordinate and conduct quality control measures utilizing Annex 17 – Aviation Security, and ICAO methodology in accordance with approved programmes.

Nominees should have already attended a specialized AVSEC training activity, such as the National Quality Control Programme Workshop and/or have regulatory experience prior to attending this course. In order to receive a certificate of successful completion, participants will be required to pass an end of course exam based on Annex 17, the ICAO Aviation Security Manual (Doc 8973-Restricted) and materials presented during the course.

Participants will be charged a course fee of **NZ\$1,163.00**. This is to cover the administration costs of the course. In addition, airfare, hotel and miscellaneous expenses will be met by the participant or their organisation.

Please be advised that your nominees should be medically fit and should either have medical insurance or medical coverage to meet expenses, if any, towards sickness or a medical emergency during attendance at the above programme. The Auckland ASTC takes no responsibility to meet expenses in this regard.
